Keynote Speakers

Prof. Daniel Béland, PhD

Director of the McGill Institute for the Study of Canada, Montréal

Daniel Béland is Director of the McGill Institute for the Study of Canada and James McGill Professor, Department of Political Science, McGill University. A student of politics and public policy, he is currently working on research projects focusing on issues ranging from universal social policy and health care reform to the role of ideas in policy development and the relationship between fiscal policy and welfare state development.

Professor Béland holds a PhD in Political Sociology from the École des Hautes Études en Sciences Sociales (Paris), where he returned as a visiting scholar in the spring of 2014. A Part-Time Professor at the University of Southern Denmark from January 2014 to December 2017, he has been a visiting scholar at Harvard University and the National University of Singapore, a visiting professor at the University of Bremen, the University of Helsinki, the University of Southern Denmark, and a Fulbright Scholar at The George Washington University and the National Academy of Social Insurance. Before joining McGill University in January 2019, he held a Canada Research Chair (Tier 1) at the University of Saskatchewan (Johnson Shoyama Graduate School of Public Policy).

Stephen Devereux, PhD

Research Fellow at the Institute of Development Studies, Brighton

Dr. Stephen Devereux is a development economist working predominantly on food security, famine, rural livelihoods, social protection and poverty reduction issues. His research experience has mainly been in eastern and southern Africa, especially Ethiopia, Malawi and Namibia.

His books include 'Fieldwork in Developing Countries', 'Theories of Famine', 'Food Security in Sub-Saharan Africa', 'The New Famines', 'Social Protection in Africa', and 'Social Protection for Africa's Children'

Prof. Patrick Emmenegger, PhD

Professor of Comparative Political Economy and Public Policy, University of St. Gallen

Patrick Emmenegger is Professor of Comparative Political Economy and Public Policy at the School of Economics and Political Science, University of St. Gallen. His research interests include the reform of coordinated models of

capitalism, the role of organized interests in the political regulation of labor markets, the historical development of the tax state, and democratic consolidation. He is also interested in institutionalist approaches and social science methodology. Patrick Emmenegger is the co-editor of the *Socio-Economic Review*, the chair of the PhD Program in International Affairs and Political Economy, and serves on the Federal Commission on Vocational Education and Training of the Swiss Government. From 2015 to 2018, he was the President of the Swiss Political Science Association.

Prof. Åsa Lundqvist, PhD

Head of the Sociology Department, Lund University, Sweden

Åsa Lundqvist's research deals with welfare politics and family relations. She has studied gender relations and the development of Swedish labour market and family policies. At present, she runs the research project "The Politics of Parenting Support". The project analyses the historical development of parenting support in Sweden and how it affects current family and gender equality ideals and ambitions. She has recently published "Transforming Gender and Family Relations. How Active Labour Market Policy Shaped the Dual Earner Model" (Edward Elgar, 2017). She is also co-author to the book *Ensamma mammor* (Gleerups, 2017).

Julia Moses, PhD

Reader in Modern History at the University of Sheffield

Julia Moses studied at Barnard College/Columbia University (New York), Oxford and Cambridge (as a Gates Scholar). Before joining the Department of History at Sheffield in September 2011, she was a lecturer at Pembroke and Brasenose Colleges, Oxford. She has been a visiting scholar at the Berlin Collegium for the Comparative History of Europe at the Free University; a professeur invitée at the École des Hautes Études en Sciences Sociales in Paris; an International Guest Lecturer at the University of Bielefeld; a Research Associate at the Max Planck Institute for Human Development in Berlin; and, a Marie Curie Fellow at the Institute of Sociology at the University of Göttingen.

Prof. Dr. Carina Schmitt

Professor of Global Social Policy at the University of Bremen

Her research interests focus on comparative welfare state research, international and comparative political economy, and quantitative methods. She worked several years on the privatization of public enterprises in rich democracies. Since 2011 she is mainly concerned with the comparative analysis of

social policy and more concretely with the diffusion and convergence of social policies. While her earlier work mainly addressed Western welfare states, she turned her research focus towards developing countries in more recent studies. In current projects, she works on the effect of colonialism on social security and social outcomes in developing countries. Methodologically, she mainly applies quantitative techniques such as panel data analyses and spatial econometrics.

Prof. Dr. Reimut Zohlnhöfer

Professor of Political Science, University of Heidelberg

Reimut Zohlnhöfer's research and the research of the graduate students and post-docs working at his chair focus on comparative public policy. More precisely, we mainly analyze economic and social policies in advanced democracies. Key explanatory variables in our research include political parties, political institutions and veto players, globalization and Europeanization. In addition, I work conceptually in the field of theories of the policy process.

Discussants

Bastian Becker, PhD

Bastian Becker is a Postdoctoral Researcher at the University of Bremen, Research Center on Inequality and Social Policy (SOCIUM) and holds a PhD in Political Science from Central European University (CEU). His main research interest lies in the political economy of inequality and redistribution, whereby he draws on comparative, historical as well as behavioral approaches. As part of the ERC project The Legacy of Colonialism, most of his current work focuses on the emergence of social policies in the developing world.

Dr. Nikolas Dörr

Nikolas works as a postdoc researcher at the SOCIUM – Research Center on Inequality and Social Policy, University of Bremen. He is currently working on a project on the relationship between war, the military and the early development of welfare states in Western Europe. Nikolas received his PhD in Modern History from the University of Potsdam in 2014 after completing his studies in Berlin, Heidelberg and Potsdam with two master's degrees in history and political science. Before he started working at SOCIUM, he worked as a researcher

for the Federal Foundation for the Study of the Communist Dictatorship in East Germany, the Centre for Contemporary History Potsdam and the German Historical Museum. His current research focus is the history of the welfare state, in particular the war-welfare nexus and the contemporary history of social policy (“activating welfare state”, New Labour, Agenda 2010). In addition, Nikolas research interests include Cold War studies, the history of international relations and the history of the labor movement.

Dr. Lorraine Frisina Doetter

Dr. Lorraine Frisina Doetter is a political scientist specializing in global developments in health and long term care. Her background is in comparative politics, including comparative research design and qualitative methods. She received her Ph.D. at the Bremen International Graduate School of Social Sciences, with Masters studies at Brooklyn College of the City University of New York, and BA studies at New York University.

Aline Grünewald

Aline Grünewald is a PhD student and lecturer at the University of Bremen. She holds a BA degree in political science and history from the University of Mannheim and a MA degree in political science from the University of Bremen. Her main research interest focuses on social policy in the global south, authoritarian regimes and party politics. In her PhD project she analyses the historical emergence of old age pension schemes around the world with a specific focus on political regime differences.

Dr. Roy Karadag

Roy Karadag’s research interests include historical sociology and Middle East politics. He wrote his PhD at the Max Planck Institut for the Study of Societies in Köln in 2010 and has been working at the Institute of Intercultural and International Studies at Bremen University since 2011. During these years, he has published on politics and capitalism, Turkey’s autocratic turn and regional power. Currently, as member of the CRC 1342, he investigates the historical dynamics of social policy making in modern Egypt.

Prof. Dr. Pauli Kettunen

Pauli Kettunen is Professor of Political History at the Faculty of Social Sciences of the University Helsinki. He was the Director of the Nordic Centre of Excellence NordWel (The Nordic Welfare State - Historical Foundations and Future Challenges, funded by NordForsk in 2007-2014). He has published widely on

welfare state, labour relations and education policies; nationalism and globalisation, and the conceptual history of politics. His most recent publications include "The Conceptual History of the Welfare State in Finland" (in *The Changing Meanings of the Welfare State: Histories of a Key Concept in the Nordic Countries*, edited by Nils Edling, 2019), "Wars, nation and the welfare state in Finland" (in *Warfare and Welfare: Military Conflict and Welfare State Development in Western Countries*, edited by Herbert Obinger, Klaus Petersen and Peter Starke, 2018) and "The Concept of nationalism in discussions on a European society" (*Journal of Political Ideologies*, 23/3, 2018).

Dr. Johanna Kuhlmann

Johanna Kuhlmann is a postdoctoral researcher in the project "Mechanisms of Social Policy Dynamics" at the Collaborative Research Center "Global Dynamics of Social Policy", University of Bremen. She received her PhD at the University of Münster in 2016. Her current research focuses on the role of causal mechanisms in comparative social policy and in theories of the policy process.

Prof. Dr. Frank Nullmeier

Frank Nullmeier is Professor for Political Science at the, University of Bremen. His Research Interests include Welfare State Theory, Social Policy, Normative Political Theory and Causal Mechanisms.

Prof. Dr. Herbert Obinger

Herbert Obinger is professor of comparative public and social policy at the University of Bremen.

He is working in the fields of comparative welfare state research and political economy. His recent work focused on the war-welfare state nexus, the politics of privatization in OECD countries, the impact of federalism on welfare state building, and welfare state transformation in small open economies. In addition, he is co-editor of the *Oxford Handbook of the Welfare State*. His articles

were published in journals such as *Journal of Public Policy*, *West European Politics*, *Journal of European Social Policy*, *European Journal of Political Research*, *Comparative Political Studies* and *World Politics*. Refereed books appeared with leading university presses such as Cambridge University Press and Oxford University Press.

Prof. Klaus Petersen, PhD

Klaus Petersen is professor in welfare state history and director of Danish Centre for Welfare Studies at the University of Southern Denmark. His main research interests include the historical development of welfare states, the Nordic model, welfare concepts and semantics, transnational social policy, and the links between (cold) war and welfare state development. In so far, his research covers the political history of the welfare state as well as in-depth studies of various policies such as old age pensions, family policy, and early retirement programs. He is currently working on topics such as: the establishment of welfare ministries, life as 90+, C. Wright Mills in Copenhagen 1956-57, social scientists use of fictional literature, and the Cold War and the welfare state. 2008-2014, he was co-editor of the seven-volume *Dansk Velfærdshistorie* [Danish welfare history] which offers the first comprehensive and detailed account of the Danish welfare state from 1800 until today. Recent publications include: *War and Welfare. Military Conflict and Welfare State Development in Western Countries* (Oxford University Press 2018, co-ed. 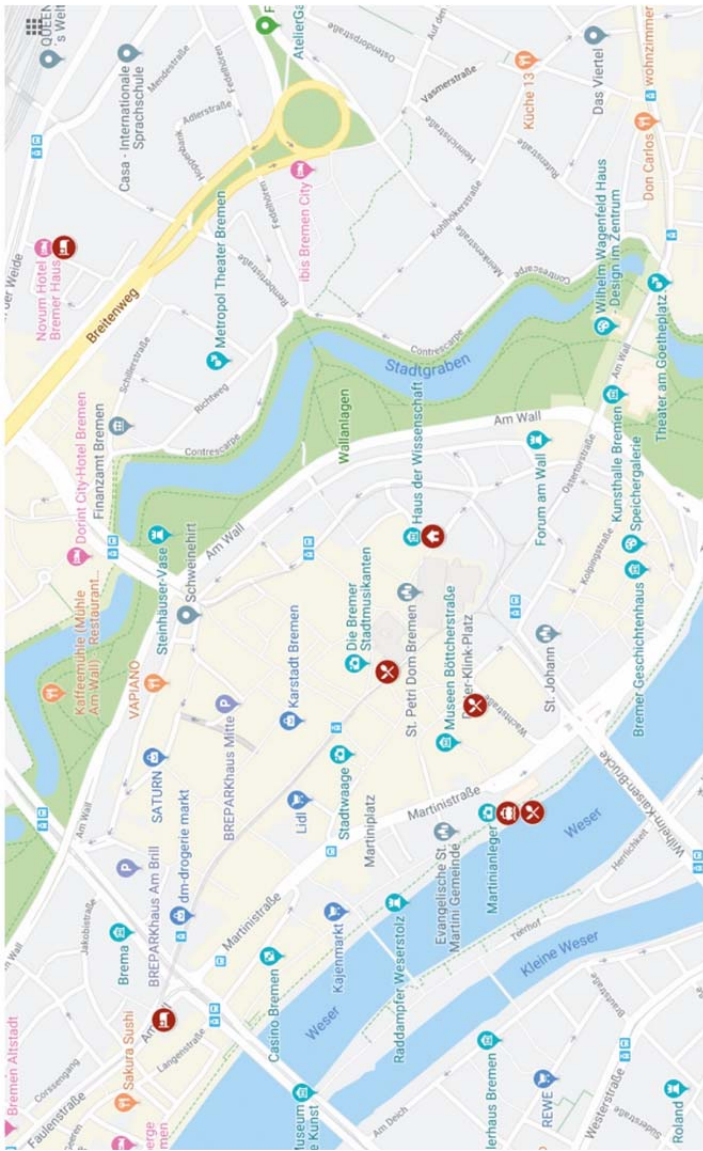
